

Grafton Select Campdraft Horse Sale 2012

Sale Conditions of Entry

- The Sale is open to well presented ridden campdraft bred horses registered or unregistered.
- Non- refundable entry fee for all horses is \$330 Inc GST. This entry fee includes all advertising, cataloguing and entitles the Sale horse entry into the 2013 Grafton Select Campdraft with a minimum pool of \$16,000.
- Horses must be **sold** at the 2012 Sale to be eligible for the 2013 Grafton Select Campdraft, which will be run as a novice draft. Any Open horse out of the 2012 Sale or any horse that breaks Open status, making them ineligible, will automatically gain free entry into the 2013 Open Draft.
- Fully paid entries must be received no later than Friday 16th December, 2011.
- Horses are to be presented in sound and suitable sale condition. The auctioneer or his representative has the right to reject any horse that is not in sale condition, unsound or incorrectly described.
- For registered horses the name of the vendor must be the same as the name of the owner under which the horse is currently registered. A copy of the horses' breed registration must accompany the entry. All original registration and breed certificates must be supplied on Sale day.
- For unregistered horses it is compulsory to complete the diagram on the reverse side of the entry form to illustrate brands and markings. An entry will be deemed invalid & not accepted if no breeding is noted.
- Any horse addicted to wind sucking or showing any symptoms of being a wobbler or roarer, must be disclosed by the Vendor to the Auctioneer prior to sale and the Auctioneer will disclose these facts at the time of sale.
- Stables will be allocated for all sale horses.
- The vendor agrees that any horse catalogued will not be sold prior to the Sale.
- Commission of 6% (plus GST) of the Sale price will be payable by the Vendor to the Auctioneer in respect of each lot catalogued and sold. This applies from the day of sale to 14 days after the advertised sale date, whether sold at Auction or by Private Treaty.
- Please complete the enclosed GST declaration, if not done previously or if your GST status has changed.
- In signing the entry form the vendor agrees to the above terms. Nomination forms without full payment and vendor's signature will not be accepted.

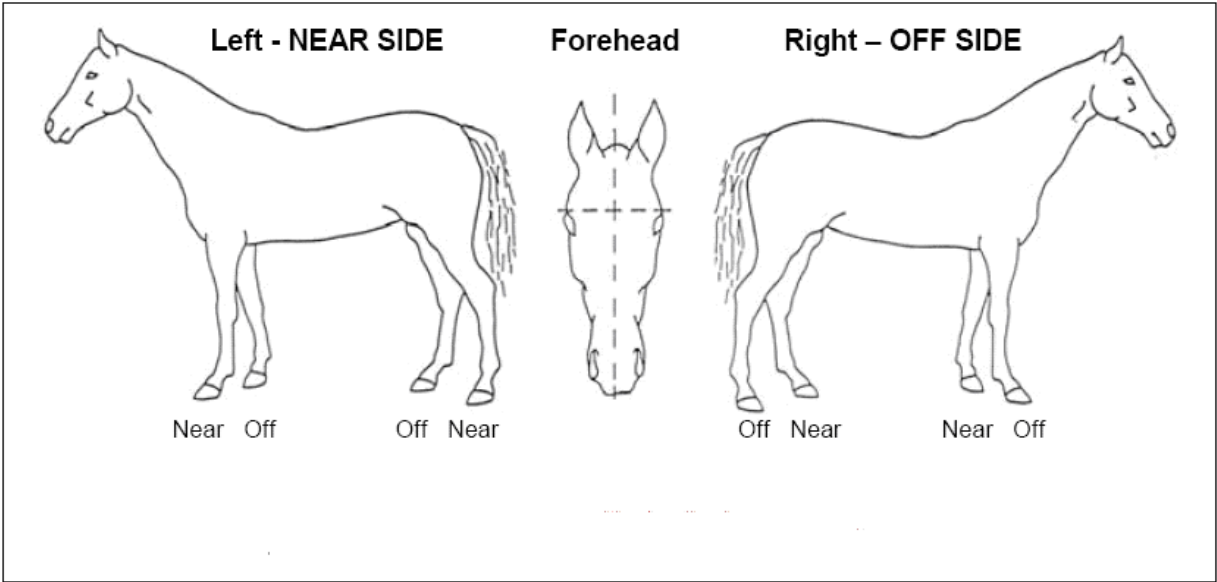
